I hereby agree that this contract is between Montessori Preparatory Academy LLC (referred, to as School) and the legal guardians of enrolling child (Student). All persons signing this contract are jointly and severally liable for tuition and fees set forth herein. Parent's signature and/or initials on this contract evidence the Parent's understanding and agreement to the terms of this contract and its contracts as follows: Student, upon acceptance, agrees to enroll for the duration of the Summer program at 2126 Edgewater Dr., Montessori Prep at the Lake, selected and indicated by parent. Student will be enrolled in an education-based program. I (parent/guardian) understand that any changes to this schedule will be accepted with a signed, new Agreement only. I understand that payment is due at the beginning of each session in full. I further understand that the overhead expenses of the School do not diminish with the departure of students during the course of the program and agree that it is impossible for the school to determine at the time of the execution of the contract the damage and or potential loss due to cancellation or withdrawal. Therefore, once this contract is submitted and registration paid, the Parent becomes liable for the entire session tuition. Extenuating circumstances, health, and military orders will be considered as situations of duress and will be evaluated separately. I understand that I may terminate Students enrollment by submitting a Written Notice of Termination. I understand that the school may terminate enrollment of Student without notice pursuant of breaches to contract, behavioral situations or without further discretion. I agree to pay for any incidental fees that may occur (lost/broken equipment, event charges, lunch fees). The parties herein agree to waive the right to a jury trial over any claims pertaining to the Student's enrollment, attendance, or separation from the School, including but not limited to claims of breach of contract under the statute, ordinance, or common law. This contract and the rights and obligations of the parties shall be governed by in accordance with laws of the state of Georgia.

Immediate suspension of the contract will be applicable and may be without notice during all periods that the school is closed because of force majeure. Parent agrees for student's photos, image, voice and work material (excluding name) to be used by School for use in publications, promotion materials, social networks, and websites without compensation and prior notice. If the parent disagrees, written notification must be provided prior to enrollment. Any and all returned checks are subjected to bank fess and \$30 returned check fee. Timeliness is imperative. All students will access a \$10 late fee for late pick-up and a \$1 a minute after 15 minutes. If 30 minutes elapse, and School is unable to contact any individuals on authorized list, the appropriate government agency will be notified. Parent agrees to sign child in and out daily. By signing this contract and agreement. Parent acknowledges that Parent understands the terms of this contract, Parent's obligations therein, responsibility concerning Students behavior, and option to terminate. Parents and or guardians maintaining legal custody are financially responsible for the Student and accept the terms of this Admission agreement.
